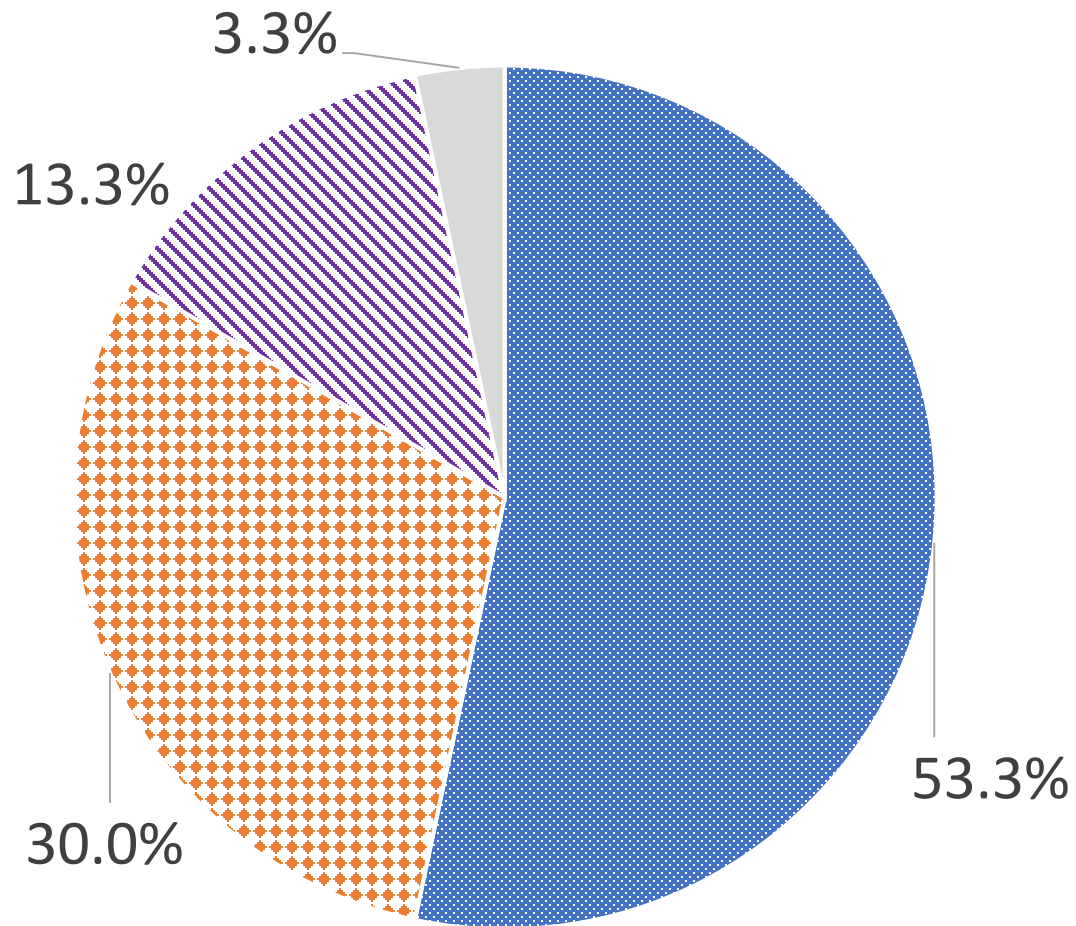

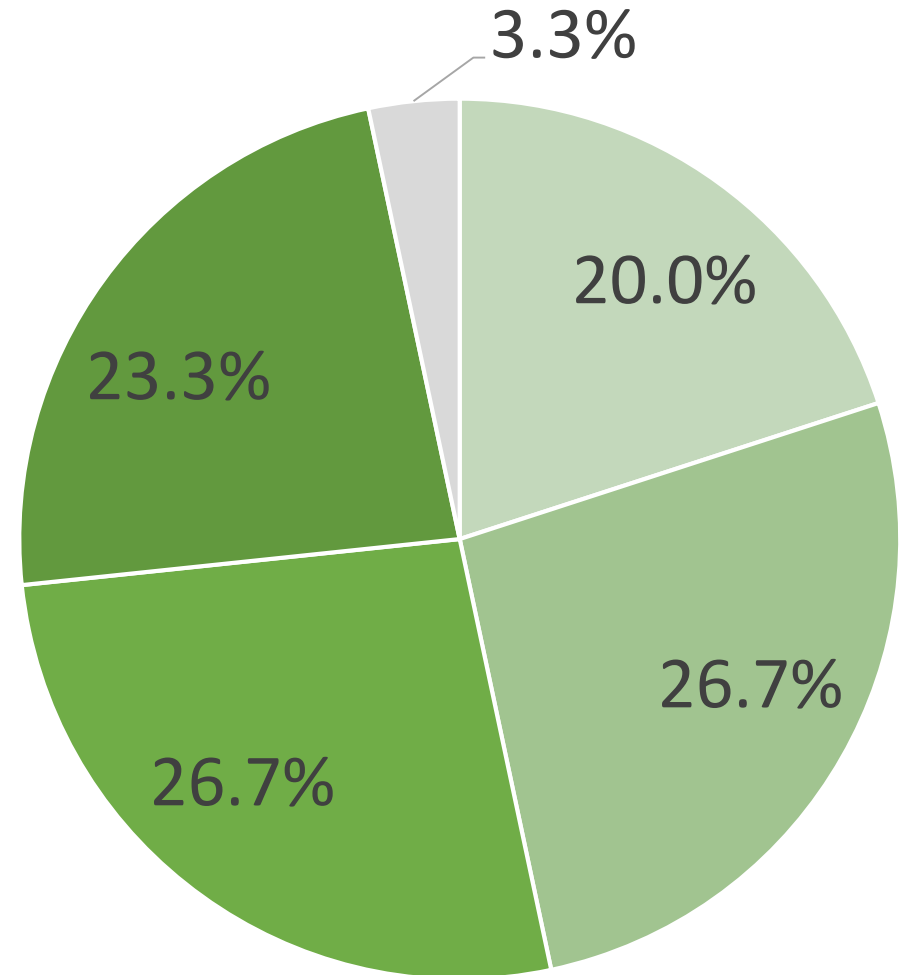
Demographics of Applicants to Greenbelt Reparations Commission

Residence in Greenbelt



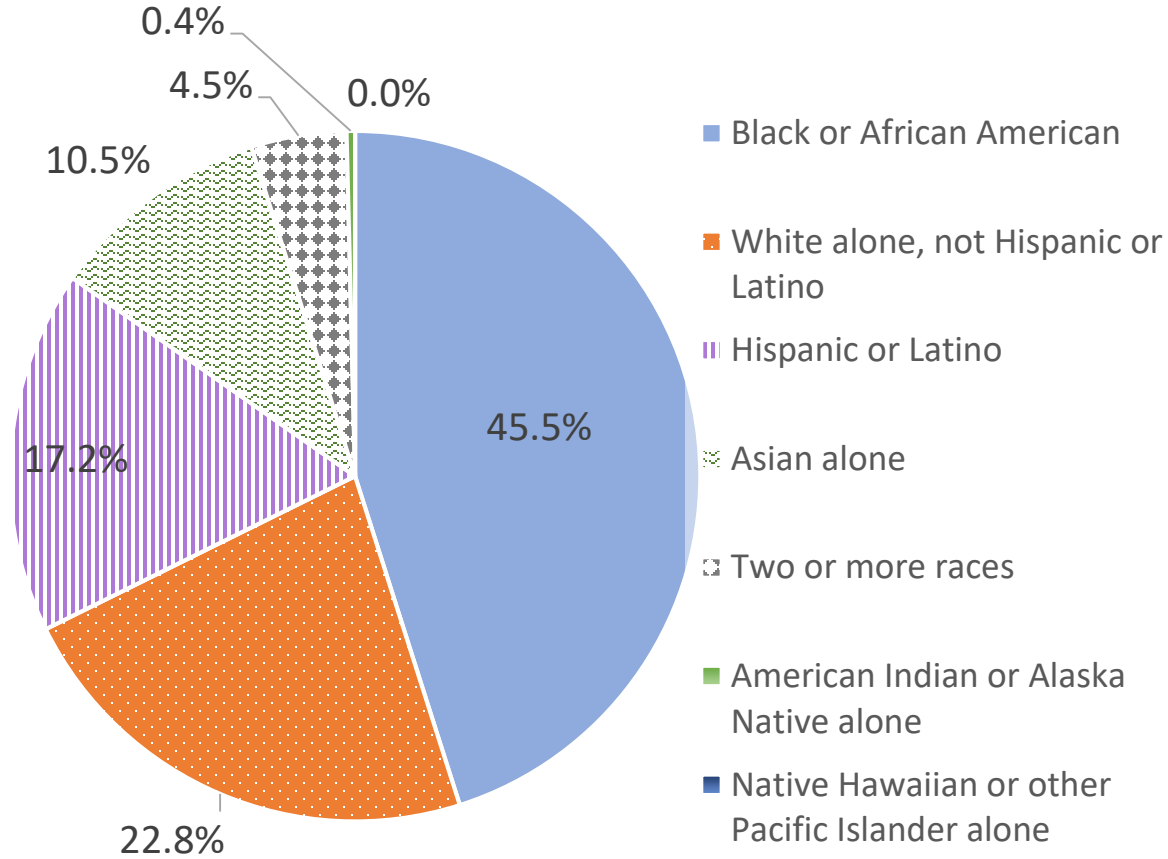

Years Lived in Greenbelt

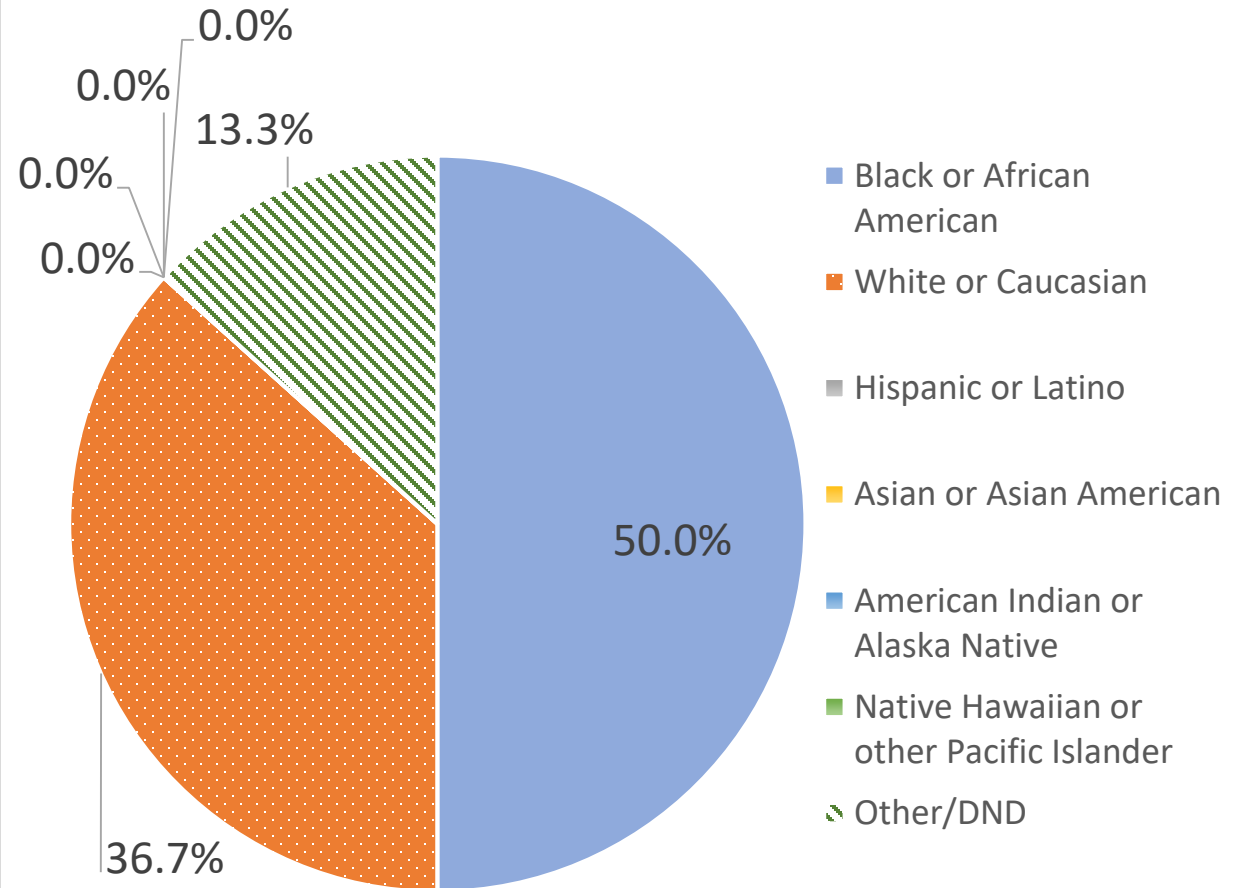

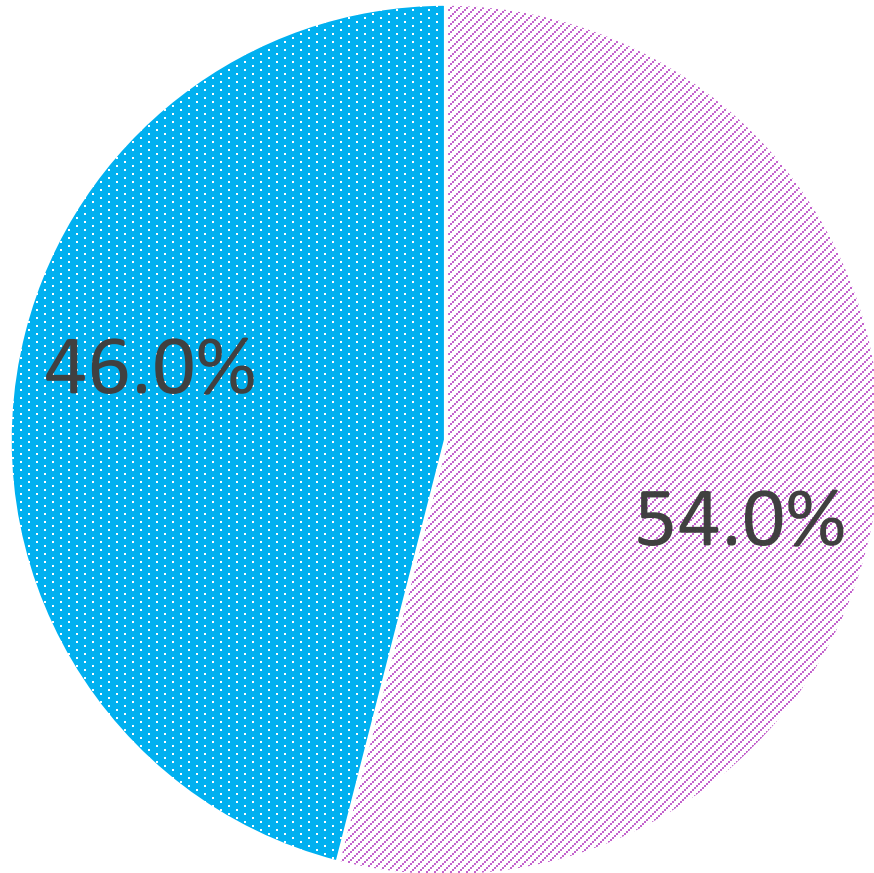
Race - Greenbelt 2020 Census



Race - Applicants

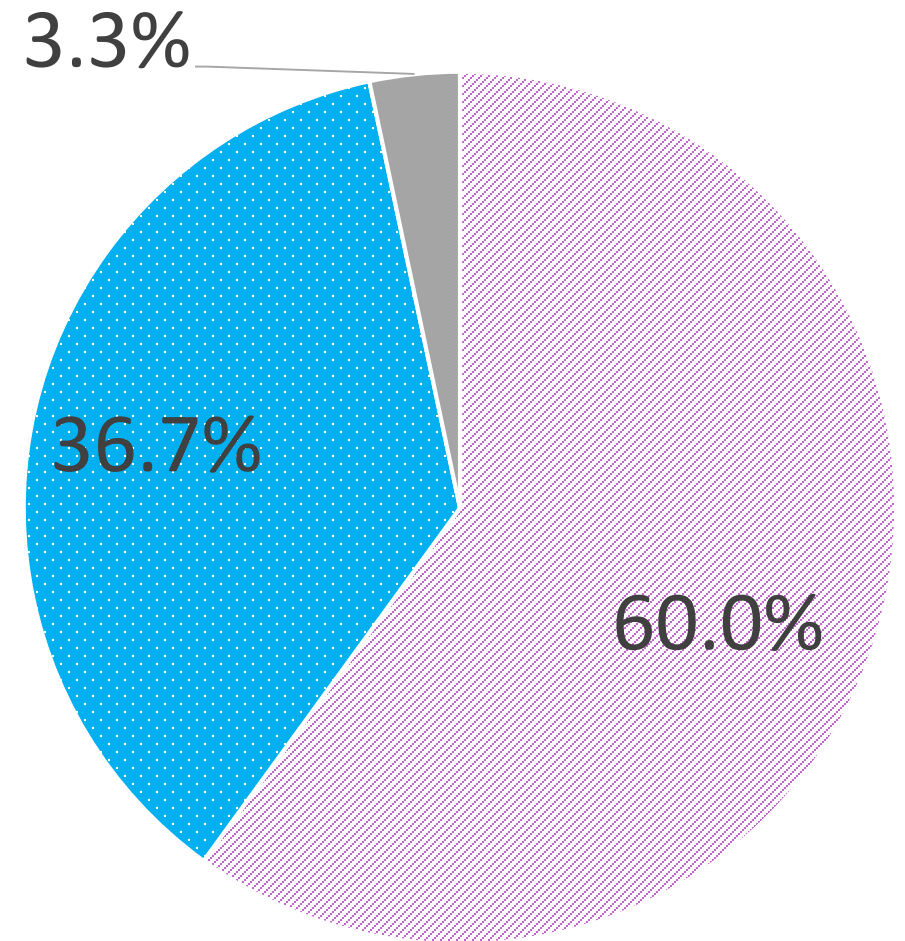


Sex - Census



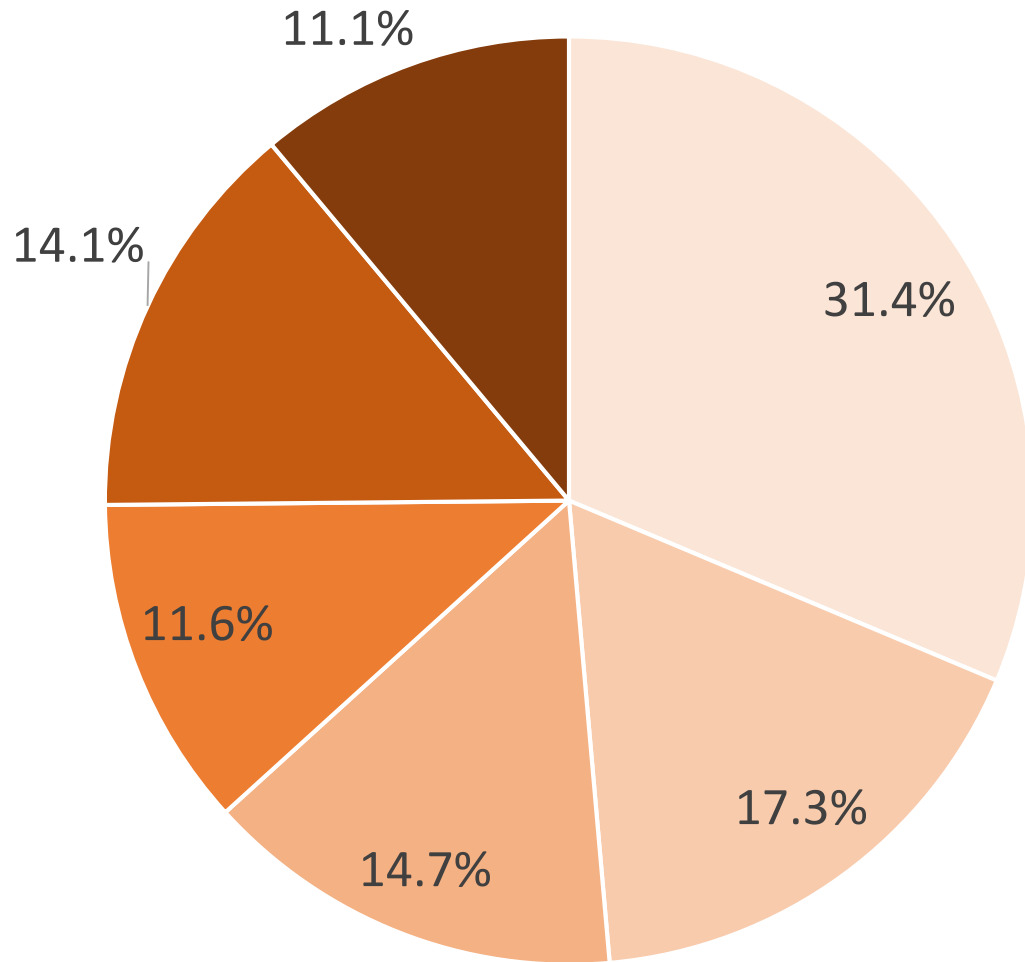

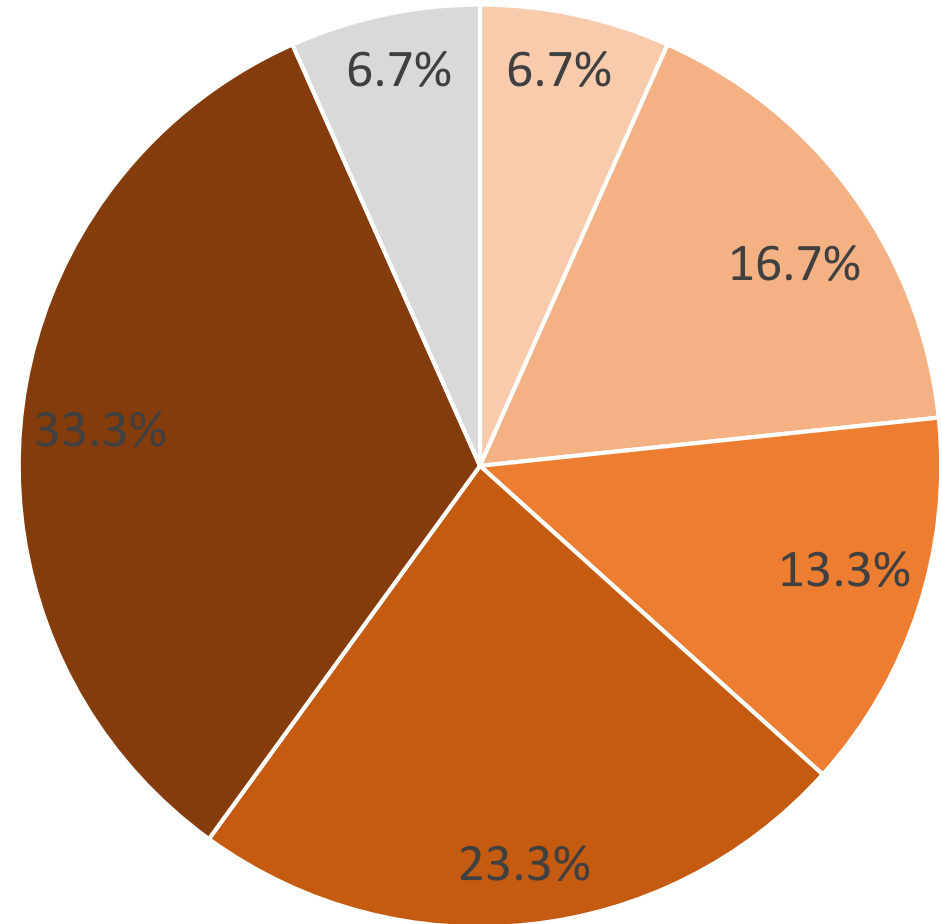

Age - Greenbelt 2020 Census



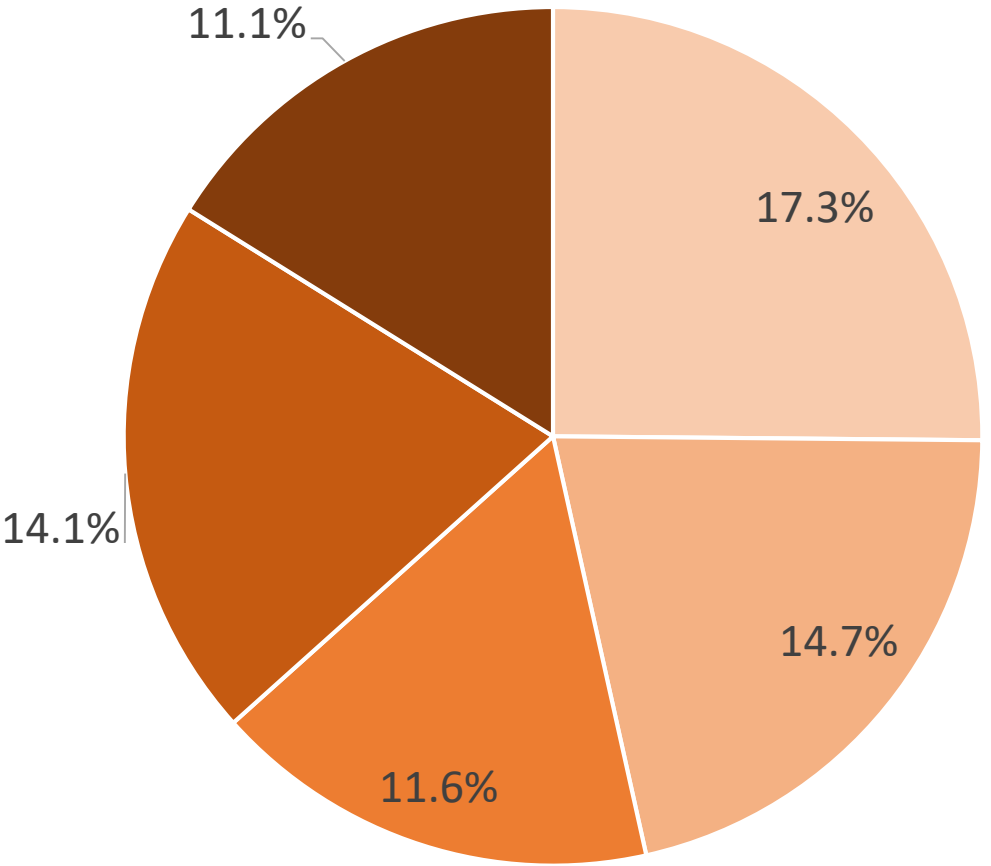

Age - Applicants



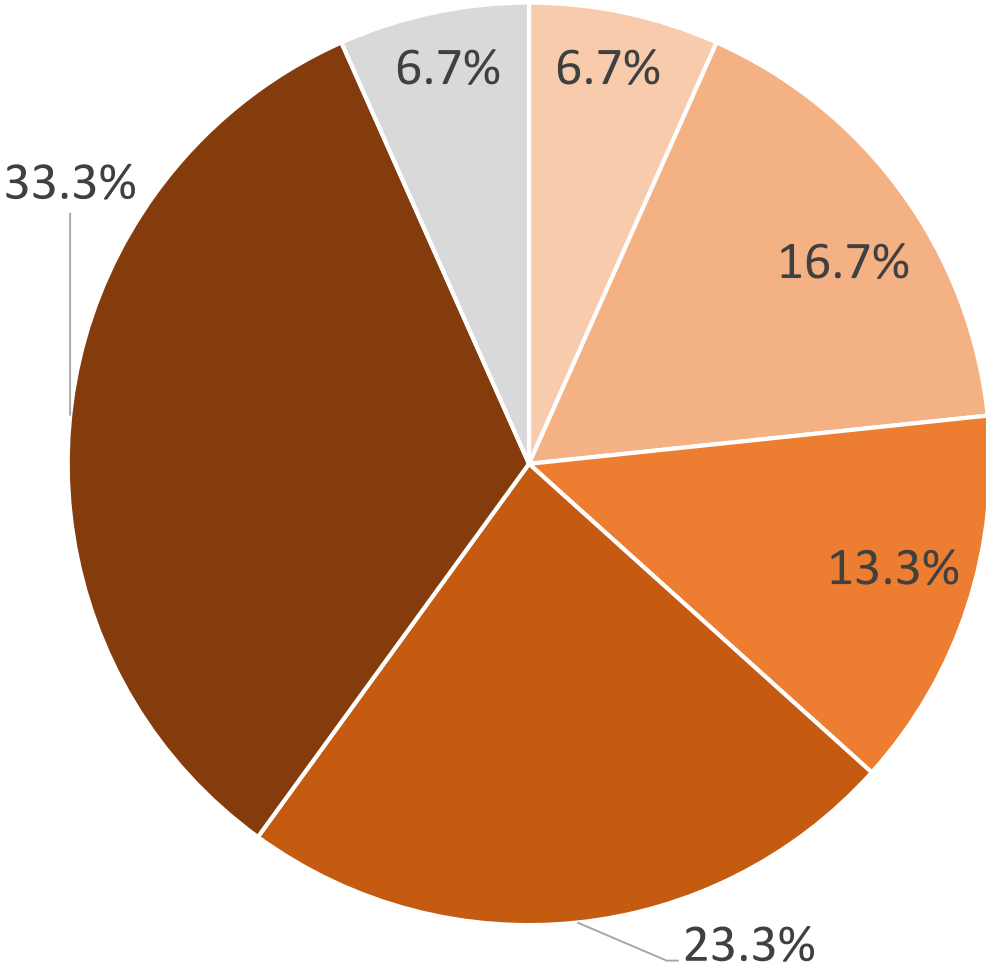
25-34 35-44 45-54 55-64 65+ DND
